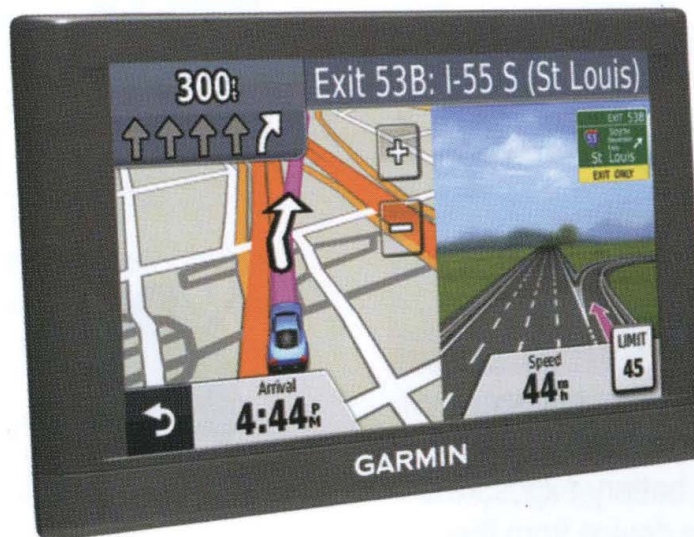

Getting Started

Mounting the Device

WARNING

This product contains a lithium-ion battery. To prevent the possibility of personal injury or product damage caused by battery exposure to extreme heat, remove the device from the

vehicle when exiting or store it out of direct sunlight.

NOTICE

Before mounting the device, see the *Important Safety and Product Information* guide for information about laws pertaining to windshield mounting.

Charge your device as you drive before using it on battery power.

- 1 Press the suction cup  to the windshield.



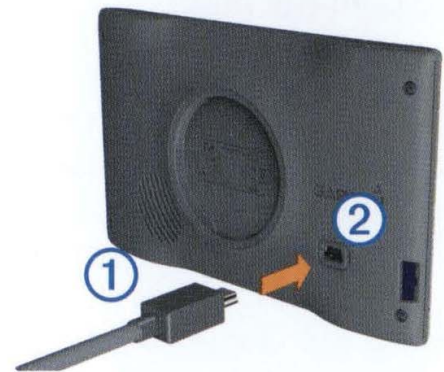
- 2 While pressing, flip the lever ② back toward the windshield.
- 3 Press the mount ③ up and into the opening on the back of the device until it snaps into place.
- 4 Plug the vehicle power cable ④ into the USB port ⑤ on the device.
- 5 Plug the other end of the vehicle power cable into a power outlet in your vehicle.
- 6 Snap the mount onto the suction cup ⑥ arm.

About Garmin Express

Use Garmin Express to register your device, check for software and map updates, access product manuals and support, and more.

Setting Up Garmin Express

- 1 Connect a USB cable ① to the mini-USB port ② on the device.



- 2 Connect the other end of the USB cable to the USB port on your computer.
- 3 Go to www.garmin.com/express.
- 4 Follow the on-screen instructions.

nüMaps Guarantee™

If you register the device at www.garmin.com/express within 90 days of acquiring satellites while driving, your device could be eligible for one free map update. Go to www.garmin.com/numaps for terms and conditions.

Activating Lifetime Maps

- 1 Go to www.garmin.com/lifetimeupdater.
- 2 Follow the on-screen instructions.

NOTE: If you register the device, you can receive e-mail notifications when a map update is available.

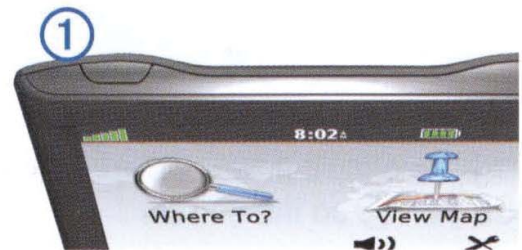
Downloading the Owner's Manual

The owner's manual for your device is available on the Garmin web site.

- 1 Open Garmin Express (page 3).
- 2 Click **Manuals**.
A list of the product manuals in several languages appears.
- 3 Click **Download** next to the manual you want.
- 4 Save the file to your computer.

Turning Off the Device

- 1 Tap the **Power** key ①.



- 2 Select **Power Off**.

Resetting the Device

You can reset your device if it stops functioning.

Hold the **Power** key for 10 seconds.

Changing the Screen Brightness

- 1 Select **Settings > Display > Brightness**.
- 2 Select  or .

Adjusting the Volume

- 1 Select **Volume**.
- 2 Select an option:

- Select  or .
- Select the **Mute** check box.

About Points of Interest

The detailed maps loaded in your device contain points of interest, such as restaurants, hotels, and auto services.

Finding a Point of Interest by Category

- 1 Select **Where To? > Points of Interest**.
- 2 Select a category.
- 3 If necessary, select a subcategory.
- 4 Select a location.
- 5 Select **Go!**.

Searching Within a Category

To narrow your search results, you can search within some categories.

- 1 Select **Where To? > Points of Interest**.
- 2 Select a category.

- 3 If necessary, select a subcategory.
- 4 Select **Spell**.
- 5 Enter all or part of the name.
- 6 Select **Done**.

Searching Near Another Location

By default, your device finds locations closest to your current location. You can find a location near another city or location.

- 1 Select **Where To? > Near**.
- 2 Select an option, and select **OK**.
- 3 If necessary, select a location.

Adding a Stop to a Route

- 1 While navigating an automobile route, select **Where To?**.
- 2 Search for the location.
- 3 Select **Go!**.
- 4 Select **Add as a Via Point**.

Saving a Home Location

You can set your home location for the location you return to most often.

- 1 Select **Where To? > Go Home**.
- 2 Select **Enter My Address, Use My Current Location, or Choose from Recently Found**.

The location is saved as “Home” in Favorites.

Following an Automobile Route

NOTICE

The speed limit icon feature is for information only and does not replace the driver’s responsibility to abide by all posted speed limit signs and to use safe driving judgment at all times. Garmin will not be responsible for any traffic fines or citations that you may receive for failing to follow all applicable traffic laws and signs.

The route is marked with a magenta line. A checkered flag marks your destination.

As you travel, the device guides you to the destination with voice prompts, arrows on the map, and directions at the top of the map. If you depart from the original route, the device recalculates the route and provides new directions.


An icon displaying the current speed limit may appear as you travel on major roadways.



Taking a Detour

While navigating a route, you can use detours to avoid obstacles ahead of you, such as construction zones.

NOTE: If the route you are currently taking is the only reasonable option, the device might not calculate a detour.

- 1 While navigating a route, select  to return to the main menu.
- 2 Select **Detour**.

Stopping the Route

While navigating a route, select  > **Stop**.

Favorites


You can save locations in your Favorites so you can quickly find them and create routes to them. Your home location is also stored in Favorites.

Saving Your Location to Favorites


- 1 From the map, select the vehicle icon.
- 2 Select **Save Location**.
- 3 Enter a name, and select **Done**.
- 4 Select **OK**.

The location is saved in Favorites.

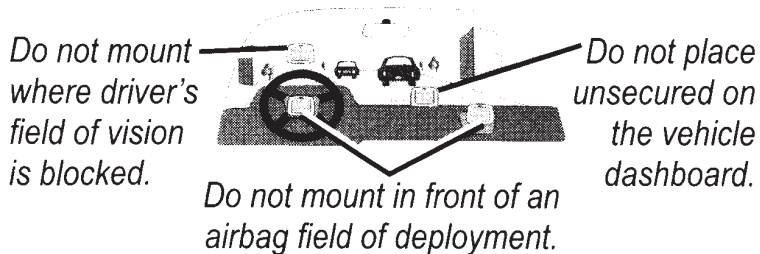
Important Safety and Product Information

! WARNING

Failure to avoid the following potentially hazardous situations could result in an accident or collision resulting in death or serious injury.

Installation and Operation Warnings

- When installing the device in a vehicle, place the device securely so it does not obstruct the driver's view of the road or interfere with vehicle operating controls, such as the steering wheel, the foot pedals, or the transmission levers. Do not place the device in front of or above any airbag. (See diagram.)



- The windshield mount may not stay attached to the windshield in all circumstances. Do not place the mount where it will become a distraction if the mount should become detached. Keep your windshield clean to help ensure that the mount stays on the windshield.
- Always use your best judgement, and operate the vehicle in a safe manner. **Do not become distracted by the device while driving, and always be fully aware of all driving conditions.** Minimize the amount of time spent viewing the device screen while driving and use voice prompts when possible.

- Do not input destinations, change settings, or access any functions requiring prolonged use of the device controls while driving. Pull over in a safe and legal manner before attempting such operations.
- When navigating, carefully compare information displayed on the device to all available navigation sources, including road signs, road closures, road conditions, traffic congestion, weather conditions, and other factors that may affect safety while driving. For safety, always resolve any discrepancies before continuing navigation, and defer to posted road signs and road conditions.
- The device is designed to provide route suggestions. It is not a replacement for driver attentiveness and good judgement. **Do not follow route suggestions if they suggest an unsafe or illegal maneuver or would place the vehicle in an unsafe situation.**

Battery Warnings

If these guidelines are not followed, the internal lithium-ion battery may experience a shortened life span or may present a risk of damage to the GPS device, fire, chemical burn, electrolyte leak, and/or injury.

- Do not leave the device exposed to a heat source or in a high-temperature location, such as in the sun in an unattended vehicle. To prevent damage, remove the device from the vehicle or store it out of direct sunlight, such as in the glove box.
- Do not puncture or incinerate the device or battery.
- When storing the device for an extended time, store within the following temperature range: from 32° to 77°F (from 0° to 25°C).
- Do not operate the device outside of the following temperature range: from -4° to 131°F (from -20° to 55°C).
